The Williamson County Sheriff's Office is currently seeking Detention Division oriented individuals. Detention Deputies assist with the care, custody and control of inmates housed in John I. Easley, Jr. Criminal Justice Center. Detention Deputies Perform duties including but not limited to:

- Assisting with the security and overseeing care and well-being of inmates
- Monitoring inmate movement within a facility and complete rounds throughout the facility
- Conducting searches of cells, inmates and visitors
- Prepare and submit appropriate criminal, disciplinary, and incident reports
- Oversee meal pass, medication pass, and any other programs as needed
- Providing inmate security on medical and other types of transports
- Assisting with inmate processing

**Working environment/Physical Demands:**

Work in the Detention Division involves high risks with exposure to potentially dangerous situations or unusual environmental stressors that require a range of safety precautions and the ability to defend one's self. Employees may be required to work varying shifts and weekends and will be required to stay over periodically to cover shifts.

**Minimum qualifications required for this position are:**

- Must successfully complete and pass Functional Fitness Test (FFT).
- Must successfully complete and pass a drug screen.
- Must successfully complete and pass a psychological assessment.

- Must qualify with agency issued sidearm.
- Must be exposed to Taser.
